Fire Regulations regarding Solvik

Earlier "Fire Regulations regarding Solvik"

The Union Council has established a fire protections policy regarding the Union. These regulations specify how the fire protection policy and legal obligations and other demands shall be achieved.

In case of fire and evacuation

- In case of fire call 112 immediately!
- The grass area next to the parking lot is the gathering place when evacuation.
- If fire is detected, if fire alarm goes off or if you suspect fire act as follows:
 - Save the people who are in immediate danger: In the event of fire it is important to save those who are in immediate danger first. Keep in mind that children and people with disabilities that impair mobility, vision or hearing and other influences that may impair the ability to react adequate in an emergency situation, need special help. Persons that are in direct danger shall immediately be removed from danger and preferably escorted to the evacuation point.
 - Alert the surroundings and begin evacuation: Keep in mind that children and people with disabilities that impair mobility, vision or hearing and other influences that may impair the ability to react adequate in an emergency situation, need special help. Those who doesn't need to organize evacuation, rescue and take care of injured or locate the fire shall leave the building immediately and gather at the evacuation point. The renter for the premises usage shall themselves or through delegation see to that evacuation continues, that no one stays in the building nor returns.
 - Alert the emergency service: If it's immediately clear that there is a fire or there is a strong suspicion (for example, through established smoke development) the emergency services shall be alerted at once on telephone number 112. The one calling should be able to answer these questions: What has happened? Where are you located? From what phone number are you calling? How many injured are there? The one in charge of the rental shall see to that someone with local knowledge meet up with the fire brigade.
 - o **Extinguish and limit the fire:** The person in charge of the rental must delegate to persons who will try to extinguish and limit the fire if they deem it possible. There are fire extinguisher and fire blankets for usage of this. It is important to demarcate the fire. It is thus important to close all doors in the house, especially those closest to the fire, as soon as possible in regard to the evacuation. Ensure that doors to flammable liquid and explosive items are closed. If it is possible to do so safely, these goods shall be moved out of the house to a safe place. If there are gas cylinders, flammable liquid or explosive items left in the building, the emergency service must be aware of where they are.
- Fire extinguisher are placed in the kitchen, next to the stove in the Great Cabin (storstugan), on the Great Cabins balcony and in the saunas antechamber.
- All fire incidents must be reported to the Sports Cabin Committee or the premises manager at MF.

Code of conduct and routines for fire protection

- It is forbidden to make a fire outdoors other than in the grills and the fixed fireplaces.
- Ensure that there are no fire ban in the area. Call Rescue service at 08-729 99 39 and make sure. If a fire ban prevails you are only aloud to fire in the round grills not in the other fireplaces outside.
- Inside you may use the stove cassettes in Great Cabin, in the sauna stove and in the stove in the bower. The tile stove may NOT be used.
- It is strictly forbidden to use lighter fluid when burning in the stove cassette in the Main Cabin or in the sauna stove.
- Flammable or explosive gases, e.g. gas oil, must not be handled or stored at Solvik.
- You must not block any door at the house or sauna for evacuation reasons.
- When furnishing in the Great Cabin there must always be a free passage to an escape route. Furniture may not be placed so that one must climb over any furniture or squeeze in between furniture when trying to evacuate the premises. The floor must be free from items so there are no risk of tripping when evacuating the premises.
- When you have made a fire or lit candles make sure someone has the fire under surveillance at all times. Blow out the candles when you are leaving them – even if it is just for a short moment. The candles must always be in/stand on material that is noncombustible materials. For example, candles shall be in candlesticks or candle lanterns in metal and not be loose on paper dishes.
- Ashes from the stoves and fire places may not be emptied outside while still warm. If you have to empty warm ashes empty it in the water.
- Check that the ashes in the fireplaces outsider really are put out. If you are unsure then you can pour a lot of water on it and stir until you can tell that nothing is glowing.
- If any of the fire alarms start to run out of batteries and begin beeping, take it down and remove the battery. Never put the fire alarm back without a battery, leave it visible at any furniture so that one of the bailiffs can replace the battery and re-install it.

Inspection and fines

- After the rental the Solvik bailiffs will inspect Solvik.
- Failure to comply with these regulations may, according to the rental contract, result in fines which will be charged after the rental.
- The Solvik bailiff who perform the inspection will decide how large amount of fines that shall be registered for every demand not obtained. Maximum amount of fines for firing in the wrong place or incorrect fire handling is 1000 SEK per point above that has not been obtained.
- For the misuse of fire protection equipment, the cost for reparation/refill will be charged.
- If a violation of these regulations leads to property damage or that MF will be accountable for other damages, the renter will be charged with fines accordingly to the contract, with the cost that has affected MF.
