## **Information to subjects registered in Medicinska Föreningen's i Stockholm member register**

Information according to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation, GDPR) Ch. 3 article 14. As a member or potential member of Medicinska Föreningen i Stockholm (MF) your personal data is processed with electronic data processing (EDP) in MF's member register.

### **Personal Data Controller**

MF is responsible for the processing of personal data in the member register. MF can be contacted via phone 08-524 830 79 or email [karx@medicinskaforeningen.se](mailto:karx@medicinskaforeningen.se) or post to Kårexpeditionen, Medicinska Föreningen i Stockholm, Box 250, 171 77 STOCKHOLM.

Within MF, the processing of personal data falls within the responsibility of the Board.

### **Personal Data Processor**

MF hires Mecenat AB as personal data processor for the processing of personal data in the member register. Mecenat may in some cases hire subprocessors for certain services.

### **Purpose with the personal data processing and legal basis**

The purpose of the processing is:

- to ensure that MF will be able to fulfil its obligations according to 4 chapter 12 and 14 §§ Higher Education Act (1992:1434). Therefore, data on students at Karolinska Institutet (KI) that are entitled to membership is also processed, in order to be able to offer these students membership.
- to ensure that MF will be able to fulfil its obligations towards the members according to the by-laws and make sure that the members fulfil their obligations towards MF.

The processing of personal data in the member register is done according to the General Data Protection Regulation (GDPR) chapter II article 6.1 b-c, e compare 2 chapter 1-2 §§ law (2018:218) with supplementary provisions to EU's GDPR (see also prop. 2017/18:218 9.2.7)

### **Data from Karolinska Institutet**



Data is provided to the member register from KI's register for student documentation, LADOK, according to 2 chapter 6 § 8 regulation (1993:1153) concerning accounts of studies etc. at universities and university colleges.

### **Direct marketing**

MF will not process your personal data for purposes connected to direct marketing if you have declared your opposition in written form towards such processing according to GDPR article 21.2-3. MF is restrictive when it comes to consignment of personal data from the member register and especially if the purpose is direct marketing. See further information below.

### **Recipients of data from the register**

MF's Union Council has decided that data from the member register may only be consigned to the following parties:

- a. the data subject
- b. printing company/distributor that is hired by MF for addressing/printing of magazine or other printed matter that MF will distribute to its members.
- c. company hired as personal data processor on behalf of MF.
- d. Stockholm Studentkårers Centralorganisation (SSCO) for Stiftelsen Stockholms studentbostäders (SSSB's) verification of student union membership for the benefit of student accommodation and housing queue.
- e. Karolinska Institutet, on demand, according to 4 chapter 14 § 3 subparagraph Higher Education Act (1992:1434).

The Board can decide on exceptions from the rule above. Such decision is valid for maximally one year and for the number of consignment occasions that the Board decides upon. When it comes to consigning addresses of the members for information/invitations, the consignment must be considered against the interest/benefit the members will have of this information.

### **Sensitive personal data**

MF does not process sensitive personal data in the member register.

### **Data that might be processed**

MF members in every member category and students at Karolinska Institutet that are entitled to membership are registered in the member register. Every member or student can have these categories of data registered: Name, personal/identity number, address and postal code, phone number and email address, sex, data on the accuracy of the address, data on member category, certificate on the right to obtain a membership, data on protected identity, data on education that is being undertaken at Karolinska Institutet, examination and if the education is undertaken as distance learning or exchange studies, study activity, status as accepted or registered in LADOK, sectional affiliation, data on payments, member cards and such, messages sent to the data subject, data on the subject's student union engagements within MF, data on received awards and data on possible claims on and disciplinary measures taken against members or previous members.

### **Right to obtain information about what data is being processed and access to it**



According to the General Data Protection Regulation chapter III article 15, you have the right to get a confirmation on whether personal data concerning you is being processed, and in the case that it is - get access to the personal data. If your personal data is processed in the member register you will receive information about which categories of personal data that are being processed, from where the data has been gathered, the purpose of the processing, information on during which period the data will be processed, to which recipients the data is being consigned and some additional information that needs to be supplied according to the General Data Protection Regulation. ### **Right to rectification**

As a subject registered in MF's member register you have the right, according to the General Data Protection Regulation chapter III article 16, to have inaccurate personal data concerning you rectified and in addition, taking the purposes of the processing into account, the right to have incomplete personal data completed. Request for rectification of inaccurate data or completion of incomplete data can be sent to Medicinska Föreningen i Stockholm, Box 250, 171 77 STOCKHOLM or by email to [karx@medicinskaforeningen.se](mailto:karx@medicinskaforeningen.se).

### **Right to erasure ("right to be forgotten")**

You have, according to the General Data Protection Regulation chapter III article 17, in some cases the right to have personal data concerning you erased, the so-called right to be forgotten. Request for erasure of data can be sent to Medicinska Föreningen i Stockholm, Box 250, 171 77 STOCKHOLM or by email to [karx@medicinskaforeningen.se](mailto:karx@medicinskaforeningen.se).

### **Right to restriction of the processing**

In some cases, you have the right to have the processing of personal data concerning you restricted according to the General Data Protection Regulation chapter III, article 18. ### **Right to lodge a complaint with a supervisory authority**

Every data subject that considers the processing of personal data concerning him or her an infringement of the General Data Protection Regulation has the right to lodge a complaint to Integritetsskyddsmyndigheten, according to the General Data Protection Regulation chapter VIII article 77.

### **Automated decision-making and profiling**

MF does not process your personal data for automated decision-making or profiling.

### **Regulation**

MF's Union Council has issued "Regulations for processing of personal data and data protection". Provisions regarding how personal data must be processed within MF can be found in this regulation. The regulation is available at MF's website and in the student union office.
